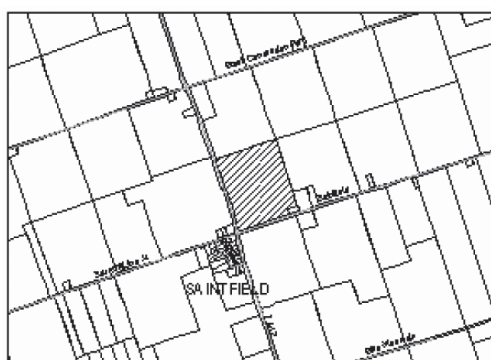

To Remove A Holding (H) Symbol Scugog Shopping Centres Limited (Smartcentres)

TAKE NOTICE that the Council of the Corporation of the Township of Scugog intends to enact a by-law amending By-Law No. 75-80 which serves to remove a Holding (H) Symbol pursuant to Sections 34 and 36 of the Planning Act, at its meeting to be held on the 30th day of June, 2008 at the Township of Scugog Municipal Office, 181 Perry Street, Port Perry.

Key Map

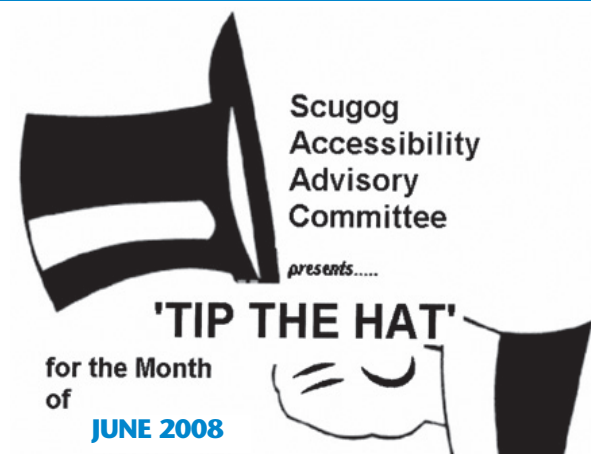
Purpose Of The Amendment

By-Law No. 70-07, enacted on May 14, 2007, served to rezone the subject land to the Special Purpose Commercial Exception Fifty-Eight Holding (C4-58-H) Zone to provide for the development of a retail shopping centre.

A Holding (H) Symbol was used to prevent the development of the property until certain conditions had been satisfied. It is now deemed appropriate to remove the Holding (H) Symbol to permit the development of the lands on the north side of Highway 7A. Removal of the Holding (H) Symbol on the lands on the south side of Highway 7A is not proposed at this time.
